FROM THE PONY Paddock

So I attempted to have a small ego boost by pursuing a "premium". Since my goal is to breed sport ponies, and being very proud of Charm's baby, Rhiannon, I decided to take her to a warmblood inspection. I thought she had a good chance to make premium. There are several choices for sport pony registries. There is NASPR (North American Sport Pony Registry), ISR Oldenburg (Oldenburg Registry North America and International Sporthorse Registry), and GOV/ Weser-Ems (The Oldenburg Horse Breeder's Society and Weser-Ems Ponies--the true daughter organization of the German Oldenburg Verband). Weser and Ems are geographic areas of Germany.

I set about researching which registry would suit better. I called friends, read web sites, checked advertising sites for prices. The best reputation may be the Weser-Ems, however my final scientific decision was based on the following sound principal: GOV inspection was the closest! There are three levels: "regular" foal registration, premium foal, and foal of distinction.

So off we went to Hillsborough. Debbie Malinowski of Wellsmont Farm hosted the inspection and put on a very nice event. There were only 9 horses/babies there to be inspected. We were last and were done by 1030 in the morning. If you want to see some gorgeous warmbloods, attend one of these inspections! The inspectors were very nice, tactful, and informative, Rhiannon was literally in the face of one of them. Rhiannon "almost" made premium!

I learned the following:

1. Expect to spend some money. One must be a member of the society and get the mare inspected in addition to inspecting the baby. Then of course you have a stall fee, a handling fee (Polly does not run) and a braiding fee. Keep in mind one is doing this for bragging rights.
2. Babies tire easily and do not show their best gaits when tired :-)
3. Read the fine points of the rulebook. In GOV if the mare does not make the main mare book, her babies can never go premium. Charm has some known conformation faults so is the "mare book", not the "main mare book". Hence none of her foals would ever go premium.
4. Expect the unexpected. I know Charm is alpha and hates other horses, especially when she has a baby. However, although I did expect her to rush at the mare next door with her ears pinned, I did NOT expect her to kick the concrete wall, thus making her lame for her inspection!

Did Charm "clean up well" and look gorgeous? Yes! Did I have a great morning? Yes! Did I get my "premium"? No. Do I still think Charm is the best pony ever and her foal is lovely? Yes! Would I do it again? Wait and see.....

FW: MOSQUITO-BORNE DISEASES – EEE FIRST CONFIRMED CASE OF 2013

In a previous Pile that was sent out was about the rains increasing some pest problems. Some problems are nuisance pests (such as millipedes) but others such as mosquitoes pose a greater problem particularly with the possibility of diseases such as Eastern Equine Encephalitis (EEE), LaCrosse Encephalitis, and West Nile Virus. As I suggested in that email, it would be prudent for horse owners to get their animals vaccinated.

Some of you may have already seen yesterday's reports that **Brunswick County had its first confirmed equine fatality from EEE.**

Despite the name, the disease affects not just horses but people as well. Unlike some other disease-causing viruses of medical importance, you can't get EEE from contact with an infected person or horse. Mosquitoes become infected when they bite an infected bird and those mosquito species then feed on other birds thus increasing the reservoir of virus in the bird population during the course of the summer. Other mosquito species that bite these same birds act as "bridges" by dining again on horses or people who now become infected.

Children and the elderly are the biggest concern and so we need to urge our clients to take appropriate protective measures and use insect repellents (see <http://insects.ncsu.edu/Urban/repellents.htm>). We still recommend the usual measures of emptying rain-filled containers and other objects as well as unclogging gutters, drainage ditches, etc. However, mosquitoes that can transmit EEE will also breed in floodwaters and salt marshes and for that reason personal protection is critical. Many of these mosquitoes are active at dawn and dusk and so altering are activity times can help (but are not a guarantee

against mosquito bites). Horse owners should consult with their veterinarian about vaccinating their animals against these mosquito-borne diseases.

People with dogs that spend a great deal of time outdoors need to make sure they are keeping up their pet's monthly heartworm medications since some of the same mosquito species that are increasing in numbers can also transmit dog heartworm.

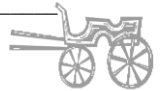

The undersigned participant, and his or her parent or legal guardian if under the age of 18 years, does/do hereby execute this release waiver, and indemnification for himself/themselves and his or her/their heirs, successors, representatives and assigns and, thereby agree(s) and represents as follows:

To release Whips and Wheels Driving Club, it's members, agents and representatives affiliated with this activity from any liability, loss, damage, costs, claims and/or causes of action, including but not limited to all bodily injuries and property damage arising out of participation in the activity, it being specifically understood that said activity includes the handling of equine by the undersigned participant. The undersigned person(s) further agree(s) to indemnify Whips and Wheels Driving Club, it's members, agents and representatives affiliated with this project, and hold them harmless for any loss, damage, cost, claim judgment, or settlement which may be brought or entered against them as a result of the undersigned person's participation in said activity.

If involved in equine activities pursuant to NC Chapter 99E of NC General Statutes, the undersigned(s) executes(s) this waiver of the undersigned(s) right to sue and agree(s) to assume all risks resulting from the "intrinsic dangers of equine activities". "Intrinsic dangers of equine activities" is defined as those dangers or conditions that are an integral part of equine activities, including but not limited to: (i) the propensity of equines to behave in ways that may result in injury, harm, or death to persons on or around them; (ii) the unpredictability of an equine's reaction to such things as sounds, sudden movement, and unfamiliar objects, persons or other animals; (iii) certain hazards such as surface and subsurface conditions; (iv) collisions with other animals or objects; and (vi) the potential of a participant acting in a negligent manner that may contribute to injury to the participant or others, such as failing to maintain control over the equine or not acting within the participant's ability.

This waiver shall remain valid unless expressly revoked by the participant or Parent or guardian of a minor. The revocation shall be in writing, which shall be addressed to the provider and shall become effective thirty (30) days after delivery to the provider.

The undersigned(s) should maintain all medical and health insurance to cover all risks of any kind in any place in livestock, equine, and/or other activities.

I the undersigned participant will ensure equipment is in good condition at all times, wear and use all safety equipment. Minors (under the age of 18) MUST wear helmets and be accompanied by an experienced driver when in the carts/carriages.

WARNING: Under North Carolina law, an equine activity sponsor or equine professional is not liable for an injury to or the death of a participant in equine activities resulting exclusively from the inherent risks of equine activities. Chapter 99E of the North Carolina general statutes.
